

Wessex Care Briefing No 4 (15/04/20)

Good News: Wiltshire has gone over a week with no new COVID 19 infections in care homes.

Wessex Care continues to test all staff three times per week and all visitors prior to attending our Care Centres. Pleased to confirm that there has been no further positive test at Holmwood following the single member of staff last month.

We continue to rigorously manage our Infection Prevention and Control IPC procedures and policies along with recommended levels of PPE in line with national guidance.

All new residents and staff continue to have quick accesses, usually before arrival, to vaccination and all staff have already been offered or received their second vaccination.

Wiltshire 'Designated Setting' COVID+ and COVID contact Hospital Discharge Support Unit at Little Manor was decommissioned at the end of March and following certified decontamination is now back operating as an Intensive Rehabilitation and Complex Care Centre. Little Manor received a CQC IPC inspection prior to closure and received a very positive report. Huge well done to everyone involved caring for a total of 57 patients during the 10 weeks of operation. The hospitals were incredibly grateful for the vital support offered during the peak of the outbreak.

Milford Manor received an unannounced CQC inspection focussed at 'Well led' and 'Is the Service Safe'. I am very pleased to confirm we maintained a rating of 'Good' in both areas and therefore we maintain our overall rating of 'Good'. We would like to take this opportunity to thank all the relatives and staff for their very kind and supportive feedback to the inspectors which is commented on in the report. To the team we want to say again a huge thank you, CQC independent inspectors have clearly supported and evidenced the quality of your service and the care you provide.
